## Kylie Millhouse Receives The DAISY Award as an Extraordinary Nurse

Kylie Millhouse of Adams Memorial Hospital was recently honored with **The DAISY Award® For Extraordinary Nurses**. The award is part of the DAISY Foundation's programs to recognize the super-human efforts nurses perform every day. The nomination submitted by the patient's daughter read, "We want to recognize how grateful we are for Kylie. I was not able to be present in the hospital with mom during her stay and it is very unnerving for me. Thank God for her nurse. She has been such a blessing to us this week. She was responsive, thorough, attentive, and gracious. She is a wonderful asset to your team! Thank You!"

The not-for-profit DAISY Foundation is based in Glen Ellen, CA, and was established by family members in memory of J. Patrick Barnes. Patrick died at the age of 33 in late 1999 from complications of Idiopathic Thrombocytopenic Purpura (ITP), a little known

but not uncommon auto-immune disease. The care Patrick and his family received from nurses while he was ill inspired this unique means of thanking nurses for making a profound difference in the lives of their patients and patient families.

Said Bonnie Barnes, FAAN, Doctor of Humane Letters and Co-Founder of The DAISY Foundation, "When Patrick was critically ill, our family experienced first-hand the remarkable skill and care nurses provide patients every day and night. Yet these unsung heroes are seldom recognized for the super-human work they do. The kind of work the nurses at Adams Memorial Hospital are called on to do every day epitomizes the purpose of The DAISY Award."

Chief Operating Officer and Nursing Officer Chris Butler stated, "Kylie defines the real meaning of what it means to serve with compassion and excellence, and she exemplifies it every day. Her contribution as a nurse at Adams Memorial Hospital and to our community reminds us of what a difference a nurse can make during a patient's hospital stay."

## **IU Simon Comprehensive Cancer Center New Community Resources & Funding Opportunity**

The IU Simon Comprehensive Cancer Center (IUSCCC) is expanding the Office of Community Outreach and Engagement (OCOE). The OCOE's mission is to lower the cancer burden in Indiana by providing a bidirectional link between IUSCCC researchers and the community we serve, with a focus on underserved populations.

Following Indiana's cancer mortality burden statistics and modifiable risk factors, the OCOE has defined cancers of the lung, breast, colon, cervix and pancreas as priority cancers. The OCOE is looking to engage with community partners at multiple levels to achieve the ultimate goal of reducing the cancer burden through influencing modifiable behaviors that influence cancer onset. These behaviors include abstaining from tobacco use, getting screened for cancer, getting vaccinated, eating healthy, and engaging in the recommended level(s) of physical activity.

Staff leads in the areas of tobacco, prevention and screening, and survivorship are partnering with community organizations to support outreach activities and policies that decrease cancer mortality and morbidity. Additionally, two annual funding opportunities via the Community-Academic Collaborative Pilot Research Award (\$15,000) and Cancer Prevention and Control Pilot Research Award (\$50,000) are available. The duration of this pilot funding is one year and applications for this round of funding are due July 15, 2022. ### Recent Ribbon Cutting Ceremony for the Rush Memorial Hospital Intensive Care Unit



The Ribbon Cutting Ceremony for the RMH Intensive Care Unit took place on Monday, May 23. RMH Board members, led by Board President John Byrne, were in attendance besides members of the RMH Administrative Council and Med Surg Director/ICU Manager Brooke Cowan. CEO Brad Smith performed the ribbon cutting.

Brad Smith, CEO, and Carrie Tressler, VP of Nursing, wanted a very sleek, modern chic look that would provide a "hands-free" environment for the staff. Design Collaborative of Fort Wayne was the architect for the project, and Harmon Construction was the general contractor selected for the job.

A variety of factors contributed to the decision to build a new ICU at RMH.

The most obvious motivation was the COVID-19 experience. During the pandemic, some RMH COVID-19 patients were obliged to travel as far as an hour away to get ICU care. This was stressful for both the patients and their families. In addition, prior to the

pandemic, the hospital only had one negative airflow room. A negative airflow room helps prevent the spread of contagious diseases within a hospital, thus protecting patients and staff. While everyone at RMH hopes that we will never have another pandemic, it was decided that the hospital needs an ICU in order to be better prepared for any future situations that might arise.

Even before the pandemic, RMH was expanding its surgical services to include hip and knee replacements, ENT and Pain Management procedures, etc. An ICU is an important safety net for surgery patients, a “just in case” back up plan that helps assure patient safety and security.

Another factor that led to construction of the ICU came from recent changes in the field of medicine itself. In recent years, more and more medical care has come to be provided on an outpatient basis. This means that patients who still need hospital care are, on average, sicker than they used to be. The safety net of an ICU here at RMH is more necessary than ever.

Of course, building an ICU is not the same as staffing one. An ICU cannot function without nurses who have ICU experience, particularly when patients need to be put on a ventilator. Fortunately, RMH is able to provide this level of nursing care.

When the ICU is fully operational, Rush County patients will no longer have to travel out of the county for intensive care services. They will be able to get the “hometown touch” of care provided by their friends and neighbors, in a state-of-the-art facility close to home. This will be easier on them and easier on their loved ones.
