



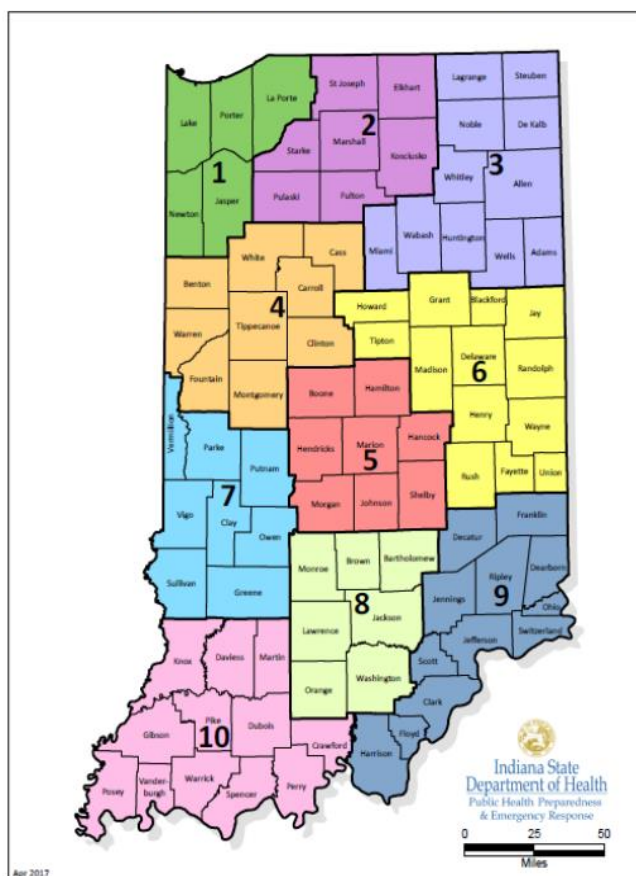

What is Medicaid?

Medicaid is a program jointly funded by the state and Federal governments, and offers free or low-cost health insurance to low-income adults, children, parents, caretakers, pregnant women, aged, blind, and disabled. There are a variety of Indiana Health Coverage Programs (IHCP) available through Medicaid. Because each of these programs serve unique populations, different eligibility factors may apply.

I am not a U.S. Citizen, may I still qualify for Medicaid?

Individuals who are not citizens of the United States may qualify for assistance based on their status granted by the U.S. Citizenship and Immigration Services. Listed below are the “qualified” immigrants as defined in federal law:

1. Lawful Permanent Resident under the Immigration and Naturalization Act (INA).
2. Asylees under Section 208 of the INA.
3. Refugees under Section 207 of the INA.
4. Parolees under Section 212(d)(2) of the INA if paroled for at least one year.
5. Persons whose deportation is withheld under Section 243(h) of the INA.
6. Conditional entrants under Section 203(a)(7) of the INA in effect prior to April 1, 1980.
7. Cuban and Haitian entrants.
8. Amerasians admitted pursuant to Section 584 of P.L. 100-202 and amended by P.L. 100-461.

I am a Lawful Permanent Residence, when am I eligible for full Medicaid coverage?

Lawful Permanent Residents who were residing in the U.S. prior to 8/22/96 are eligible for full Medicaid coverage. However, LPRs who enter the U.S. on and after 8/22/96 are eligible for emergency coverage only for 5 years unless they are honorably discharged U.S. veterans or in active duty in the U.S. military. Lawful Permanent Residents should present USCIS Form I-551 as documentation of their immigration status.

I have fled from a Communist/Communist-dominated country, the Middle East or I am refugee of a natural catastrophe. Can I apply for Medicaid?

Individuals with this status can be eligible for full Medicaid coverage. Verification is established by viewing USCIS Form I-94, Arrival-Departure Record, bearing the stamped legend "Refugee - CONDITIONAL ENTRY." Refugees usually adjust to Lawful Permanent Resident status after 12 months in the U.S.

I am a Cuban or Haitian Entrant, am I eligible for Medicaid?

Cuban and Haitian entrants, as defined in Section 501(e) of the Refugee Education Assistance Act of 1980, can be eligible for full coverage Medicaid.

Can a non-citizen pregnant woman apply for Hoosier Healthwise or Healthy Indiana Plan?

To be eligible for an IHCP program, individuals must be a United States Citizen, United States non-citizen national, or have qualified immigration status (Example: five years lawful permanent residency). Our team of licensed Indiana navigators can assist those with questions or uncertainty regarding immigration status.

For non-citizens whose immigration status does not meet the requirements to obtain health coverage through an IHCP, one can apply for limited service coverage. In October of 2019, IHCP added a new package to expand benefits for qualifying immigrants: “Package B-Emergency Services Only Coverage with Pregnancy Coverage.” Package B will cover prenatal and postpartum services in addition to emergency services only, which includes labor and delivery.

I lack immigration documentation or I cannot verify my immigration status, what are my Medicaid options?

Individuals who lack documentation or cannot verify their status can only be eligible for Emergency Medicaid coverage only.

1. It is important to remember that the eligibility restrictions and prohibitions apply only to the applicant's immigration status, not other family members.
2. If they do not verify immigration status within the 90-day timeframe from notice to provide immigration status was sent and the immigration status is not electronically verified within 95-days from when the form was sent, then the eligibility must be changed to emergency services only.

Certain visitors and non-immigrants, as described below, may be eligible for emergency Medicaid coverage. They must meet all eligibility requirements except the factor of citizenship/immigration status and Social Security numbers.

These non-citizens would have the following types of documentation:

- I-94, Arrival - Departure Record
- I-185, Canadian Border Crossing Card
- SW-434, Mexican Border Visitor's Permit
- I-186, Non-Resident Alien Mexican Border Crossing Card
- I-95A, Crewman's Landing Permit
- I-184, Crewman's Landing Permit and Identification Card.

I only qualify for Emergency Services, what am I eligible for under this category?

Emergency services are defined as services required for a medical condition (including labor and delivery) manifesting itself by acute symptoms (including severe pain) serious enough that the absence of immediate medical attention could reasonably be expected to result in serious jeopardy to the individual's health, serious impairment to bodily functions, or serious dysfunction of any bodily organ or part.

Important Things to Remember

Under no circumstances, are immigrants who lack immigration documentation or whose immigration status cannot be verified, who are applying for or receiving traditional Medicaid or Hoosier Healthwise, to be reported by the Division of Family and Children to the U.S. Citizenship and Immigration Service (USCIS). This also applies to family members of such applicants.

- If you do not speak English, that is okay. We have the ability to conduct 3-way calls with an interpretation service company that provides translations for over 20 languages.
- Eligibility requirements for programs can and do change. The information provided above is current as of the date this document was produced.
- Our navigators will consider each person's unique situation on a case-by-case basis. Extenuating circumstances may require additional research and/or documentation beyond what is traditionally requested.
- A Managed Care Entity (MCE) such as MHS, MDWise, etc., needs to be chosen by HHW members. Important factors to consider when choosing an MCE include provider networks, special programs, and enhanced services offered by the MCE. See the "Hoosier Healthwise Plan Summary" at the end of this document for details.
